# HOA Dues & Road Assessments

Legal reviewed CWC Covenants, Article II, Paragraphs 9 - 11. Based on legal's recommendation the Board voted to take the following actions in order to be in alignment with CWC Convenants:

 Each homeowner was charged \$450 for HOA Dues in January 2023. Since 2022 Dues were \$300, the HOA can only raise dues by 125% (Paragraph 9). Therefore, HOA Dues for 2023 should be \$375. A credit of \$75 will be added to your Road Assessment invoice.

- o Road Assessments shall be limited to \$500 per lot per year (Paragraph 10). With the approval of 75% of the members of the association, the Board may establish assessments in excess of the maximums (Paragraph 11). Since a vote was not completed to approve \$550 for 2023 Road Assessments, each lot owner will be charged \$500 (not \$550). Road Assessment invoices will be mailed on July 1st, due July 31, 2023.
- In summary, each homeowner (who paid \$450 HOA dues in January) will be invoiced for \$500 for Road Assessment fees with a \$75 credit for HOA dues, for a total amount due of \$425. We apologize if this caused any inconveniences.
- o This will cause an impact on the 2023 Budget and will be closely monitored.

# • Spring Clean-up – Everyone is Invited!

In order to control costs and to promote community gatherings, the Cottonwood Creek Spring Clean-up has been scheduled for Saturday, April 29, 2023. Meet at the Estates entrance at 9:00 a.m. where the fun will begin! Rain date scheduled for Saturday, May 6<sup>th</sup> at 9 a.m.

We will be mulching, cleaning up flower beds, trimming bushes, fence repair, staining posts/signage, the path, etc. If you know of other areas that need attention, please notify Chris Stanek at your earliest convenience. If you have yard tools; clippers, rakes, shovels, wheelbarrows, UTV that is capable of hauling mulch/trash are all welcome.
